## ORDER:

1. The RTI application is dated **06.09.2023** vide which the appellant has sought information regarding:

- 2. This case was last Heard by the Former SIC, Sh. Anumit Singh Sodhi and now it has been reallocated to the undersigned vide Commission's Order Dated 08.02.2024. Both parties are absent without intimation.
- 3. The Commission has gone through the case file and is of the view that all the points as enumerated in the RTI application of the appellant have been adequately addressed by the respondent PIO. There is however no communication received from the appellant to this Commission, which compels the conclusion that he is satisfied with the information provided to him by the respondent PIO.
- 4. The appeal is accordingly, **Disposed of.**
