2. The representative of the respondents requested for the adjournment of the case for one week to supply the complete information in this case. Accordingly, the request of the respondent-Public Information Officer is accepted and the case is adjourned with the directions to supply the complete information in this case failing which the show cause notice will be issued on the next date of hearing for the imposition of penalty and award of compensation in this case.

It is also a fact on record that the appellant filed the complaint case regarding this RTI application in this case which was remanded back to Dr. Deepak Bhatia, PCS, First Appellate Authority-cum-S.D.M. Ajnala with a liberty to the appellant to file the 2nd appeal. Now the appellant filed the 2nd appeal and brought to the notice that the First Appellate Authority has not passed any order. Since, the specific order was sent to Dr. Deepak Bhatia, PCS. Due to non compliance of the order of the Commission, the case file is being sent to the Chief Secretary, Punjab with the recommendation of disciplinary action against Dr. Deepak Bhatia, PCS as per the provisions of the RTI Act, 2005.

3. Accordingly, the case is adjourned.
