

3. In view of the above, the Commission deems it appropriate to impose a penalty on the respondent PIO, who was incumbent on the date of the RTI application, which is 30.3.2022.

Order: Keeping all the facts of the case in mind, this is a fit case to invoke Section 20 of RTI Act and impose a penalty on the respondent PIO Section 20(1), which reads as under:

"Where the Central Information Commission or the State Information Commission, as the case may be, at the time of deciding any complaint or appeal is of the opinion that the Central Public Information Officer or the State Public Information Officer, as the case may be, has, without any reasonable cause, refused to receive an application for information or has not furnished information within the time specified under sub Section (1) of Section 7 or malafidely denied the request for information or knowingly given incorrect, incomplete or misleading information or destroyed information which was the subject of the request or obstructed in any manner in furnishing the information, it shall impose a penalty of 250/- Rupees each day till application is received or information is furnished, so however, the total amount of such penalty shall not exceed Twenty Five Thousand Rupees;

Provided that the Central Public Officer or the State Public Information Officer, as the case may be, shall be given a reasonable opportunity of being heard before any penalty is imposed on him:

Provided further that the burden of proving that he acted reasonably and diligently shall be on the Central Information Officer, as the case may be."

The onus and responsibility lie on the PIO to ensure the transmission of the complete information to the appellant. The <u>PIO-cum-BDPO</u>, <u>Fazilka</u>, <u>who was incumbent on 30.3.2022</u>, is hereby held guilty for not providing the information on time as prescribed under Section 7, which is within 30 days of the receipt of the request and for repeated and willful defiance of the Punjab State Information Commission's orders.

A <u>penalty of Rupees Twenty Five Thousand (Rs. 25000.00)</u> is hereby imposed upon the <u>PIO-cum-BDPO</u>, <u>Fazilka</u>, <u>who was incumbent on 30.3.2022</u>, which be deducted from his salary and deposited in the Punjab Government Treasury under head "0070-Other Administrative Services-60-other Services-800-Other Receipts-86-Fees Under the Right to Information Act." The <u>PIO-cum-BDPO</u>, <u>Fazilka</u>, is directed to duly inform the Commission of the compliance of the orders by submitted a copy of the challan, to the Commission. Copies of this order be sent to the parties through registered post.

- 4. The Commission further deems it appropriate to award a compensation to the appellant Sh. Girdhari Lal, who has made to much suffer for no fault of his own.
- 5. In view of the harassment and detriment caused to the <u>appellant, Sh. Girdhari Lal</u>, this Commission deems it appropriate to award a <u>compensation of Rupees Fifteen Thousand (Rs. 15,000.00)</u>. This is to be paid vide a crossed cheque / demand draft, by the Public Authority, in this instance, <u>the office of, BDPO,Fazilka</u>, within 30 days of receiving this Order. Proof of payment is to be submitted to this Commission.
