ORDER

ORDER

The RTI application is dated 20.5.2020 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter called FAA) on 22.6.2020 and second appeal was filed in the Commission on 11.8.2020 under Section 19 of the Right to Information Act, 2005 (hereinafter called RTI Act). Notice of hearing was issued to the parties for today.

2. The appellant has sought the following information:-

1. ਮੇਰੀ ਉਕਤ ਦਰਖਾਸਤ ਉਪਰ ਕੀ ਕਾਰਵਾਈ ਕੀਤੀ ਗਈ।
2. ਟੋਭੇ ਦੀ ਨਿਸ਼ਾਨਦੇਹੀ ਕਦੋ ਕਰਵਾਈ ਗਈ।
3. ਟੋਭੇ ਦੀ ਜਗ੍ਹਾ ਤੇ ਕੀਤੇ ਨਜਾਇਜ ਕਬਜਿਆ ਸਬੰਧੀ ਕੀ ਕਾਰਵਾਈ ਕੀਤੀ ਗਈ ਹੈ।
4. ਟੋਭੇ ਵਿਚ ਜੋ ਅਵਾਰਾ ਪਸ਼ੂ ਡਿੱਗ ਕੇ ਮਰ ਰਹੇ ਹਨ ਉਸ ਸਬੰਧੀ ਕੀ ਪ੍ਰਬੰਧ ਕੀਤਾ ਗਿਆ ਹੈ।”

3. A message has been received from the appellant through whatsapp that he has received the concerned documents. The appellant was contacted on phone also and he shows his satisfaction with the information so supplied by the respondents and has no objection in case this case is disposed of.
