In addition, the PIO O/o Nagar Panchayat Narot Jaimal Singh Gurdaspur is directed to furnish an affidavit providing therein the factual situation and affirming the position that the information sought by the appellant has been supplied to their best extent. In case the partial information is not available in the office record then also an undertaking/affidavit may be filled in this regard also to the appellant with a copy to the Commission therein mentioning the reasons for its non-availability.

A Compliance report shall be submitted by the Respondent before the Commission within 45 from issue of this order.

With these directions the case is disposed of and closed.
