

- 2. The case has been heard today. Shri Kuldip Singh Walia, appellant has neither come present to attend the hearing in person nor through Cisco Webex. - 5. The Bench, on examining the information supplied by the PIO, observes that the appellant has been given para wise reply along with the relevant documents sought by the appellant. The Bench also observes on hearing the version of the appellant that he is unaware of the contents of present appeal case and rather, he is possibly mixing the contents of this appeal case with some other appeal case. The Bench is thus, convinced that adequate information stands supplied to the appellant.
- 6. In view of the above, the Bench does not feel need for further intervention in the matter. **The**instant appeal case is disposed off and closed. Copies of the order be sent to the concerned parties.
