ORDER:

The RTI application is dated 03.01.2020 vide which the Appellant has sought information as enumerated in his RTI application from the PIO O/o Municipal Corporation, Amritsar as under: -

- 2) ਮਾਨਯੋਗ ਕਮਿਸ਼ਨਰ ਨਗਰ ਨਿਗਮ ਵਲੋਂ ਆਦੇਸ਼ ਮਿਤੀ 09.10.2019 ਪੱਤਰ ਨੰਬਰ ਸੀ/472 ਰਾਹੀਂ ਸੰਯੁਕਤ ਕਮਿਸ਼ਨਰ ਜੀ ਨੂੰ ਨਗਰ ਨਿਗਮ ਦੇ ਲਾਪਰਵਾਹ ਪਬਲਿਕ ਸੂਚਨਾ ਅਧਿਕਾਰੀ ਅਤੇ ਸਹਾਇਕ ਪਬਲਿਕ ਸੂਚਨਾ ਅਧਿਕਾਰੀ ਜੋ ਪਬਲਿਕ ਦੀਆਂ ਆਰ.ਟੀ.ਆਈ. ਦੀਆਂ ਬੇਨਤੀਆਂ ਦਾ ਜਵਾਬ ਸਮੇਂ ਸਰ ਨਹੀਂ ਦਿੰਦੇ ਉਨ੍ਹਾਂ ਖਿਲਾਫ ਕਾਰਵਾਈ ਕਰਨ ਸੰਬੰਧੀ ਆਦੇਸ਼ ਜਾਰੀ ਕੀਤੇ ਸਨ ਇਨ੍ਹਾਂ ਆਦੇਸ਼ਾਂ ਮੁਤਾਬਕ ਅੱਜ ਤਕ ਜੋ ਕਾਰਵਾਈ ਕੀਤੀ ਗਈ ਉਸ ਦੇ ਰਿਕਾਰਡ ਦੀਆਂ ਕਾਪੀਆਂ ਦਿੱਤੀਆਂ ਜਾਣ ਜੀ।”

APPEAL CASE NO. 2160 OF 2020

When no information has been received from the PIO, he has filed First Appeal with the First Appellate Authority (hereinafter FAA) on 17.02.2020 but no reply has been received from him and he has filed Second Appeal in the Commission on 11.08.2020 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act) and as such Notice of hearing was issued to the parties for 29.09.2020.

During the hearing dated 29.09.2020, the Appellant stated that no information has been provided to him by the Respondents whereas the Respondent was absent. The matter was adjourned to 29.09.2020.

The matter is taken up today. The Respondent states that he has sent the reply to the Appellant and copy of the same has been emailed in the Commission mentioning therein: -

- 1) ਲੜੀ ਨੰ: 1 ਰਾਹੀਂ ਮੰਗੀ ਗਈ ਸੂਚਨਾ ਦੇ ਸਬੰਧ ਵਿੱਚ ਦੱਸਿਆ ਜਾਂਦਾ ਹੈ ਕਿ ਮਾਨਯੋਗ ਕਮਿਸ਼ਨਰ ਨਗਰ ਨਿਗਮ ਵਲੋਂ ਆਦੇਸ਼ ਨੰਬਰ ਸੀ/472, ਮਿਤੀ 09.10.2019 ਸੰਯੁਕਤ ਕਮਿਸ਼ਨਰ ਦਫਤਰ ਵਿਖੇ ਪ੍ਰਾਪਤ ਨਹੀਂ ਹੋਏ ਹਨ। ਇਸ ਲਈ ਇਹਨਾਂ ਹੁਕਮਾਂ ਦੇ ਸਬੰਧ ਵਿੱਚ ਕੋਈ ਮੀਟਿੰਗ ਨਹੀਂ ਕੀਤੀ ਗਈ।
- 2) ਲੜੀ ਨੰ: 2 ਰਾਹੀਂ ਮੰਗੀ ਗਈ ਸੂਚਨਾ ਬਾਰੇ ਸੰਯੁਕਤ ਕਮਿਸ਼ਨਰ ਦਫਤਰ ਵਿਖੇ ਕੋਈ ਰਿਕਾਰਡ ਉਪਲਬਧ ਨਹੀਂ ਹੈ।”

The Appellant states that incomplete information has been supplied to him by the Respondents. The RTI application of the Appellant discussed during the hearing. After discussion, the Commission observes that sufficient reply has been supplied to the Appellant and no further action is required on behalf of the Commission. Therefore, the Appeal case is **Disposed of and Closed**. Copies of the order be sent to the parties.

6. *Mention the names of the officials, tasks allotted to them for public dealing and their ID numbers through which they conducted the scrutinizes of learning licenses, photo, computer tests, approvals and prints of these licenses respectively.*
7. *Mention the mobile numbers of the officials which were linked to the Vahan-4 Login ID's used for processing of learning licenses for the above said period."*

Vide dated 25.02.2020, he has received the incomplete information from the Respondents then, he has filed First Appeal with the First Appellate Authority (hereinafter FAA) on 12.06.2020 but no reply has been received from him and he has filed Second Appeal in the Commission on 14.08.2020 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act) and as such Notice of hearing was issued to the parties for 29.09.2020.

During the hearing dated 29.09.2020, the Respondent stated that requisite information has already been provided to the Appellant whereas the Appellant states that he has not received the information relating to point no. 2 & 7 of his RTI application. The matter is adjourned for 19.11.2020.

The matter is taken up today. The Respondent states that remaining information has already been supplied to the Appellant. The Appellant confirms that he has received the remaining information and wants to close the case.

In view of the aforementioned, no further action is required in this case. Hence the Appeal Case is **disposed of and closed**. Copies of the order be sent to the parties.
