4. After examining the documents placed in the case-file, it is found that the respondent PIO through a reply vide letter no. 99 dated 16.06.2022, has intimated the Commission that the information sought through the RTI request is 'third party' information.

5. The complainant, Sh. Deepak , who appeared in person in today's hearing, states that no information has been given to him till date. Moreover, the information demanded by him is not third party as he himself is residing in 'Sunny Enclave' and one of the house owner .

6. In view of the foregoing, **a show cause notice under Section 20 (1) of the RTI Act is issued to Public Information Officer office of Executive Officer, Nagar Council, Kharar, as to why penalty be not imposed upon him for willful delay/denial in supplying the information to the RTI applicant and why the compensation be not awarded to the information-seeker under the provisions of the RTI Act, 2005.**

7. He may note that in case he does not file his submission and does not avail himself of the opportunity of personal hearing on the next date fixed in the office of State Information Commission, Punjab, Chandigarh, it will be presumed that he has nothing to say and the Commission shall proceed to take further proceedings against him ex-parte.
