ORDER

The RTI Application is dated 09.12.2021 vide which the appellant has sought information as enumerated in his RTI Application. First appeal was filed with the First Appellate Authority (hereinafter called FAA) on 08.01.2022 and Second Appeal was filed in the Commission on 04.03.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter called RTI Act). Notice of hearing was issued to the parties for today i.e. 19.05.2022.

2. office. But the appellant submits that he is having the letters in which it has clearly mentioned that the demarcation has been done pertaining to the road.

3. After the hearing is over, the appellant sent the letters of Gram Panchayat in which it is written that the demarcation has been done and other letter in which the Naib Tehsildar Tarsikka informed that during 2021-2022 no demarcation has been done from Road Dehriwal to Sarja.

4. After detailed deliberations with both the parties the directions are issued to the respondent-Public Information Officer to clarify the same and also directed to file the reply/supply the information as has been sought by the appellant before the next date of hearing failing which the punitive action will be initiated on the next date of hearing. A copy of the RTI application is again being **sent** along with this order.

5. Also, a copy of this order is being sent to the Block Development and Panchayats Officer, Tarsika along with the RTI application of the appellant to ensure compliance of this order.

ORDER

The RTI Application is dated 28.12.2021 vide which the appellant has sought information as enumerated in his RTI Application. First appeal was filed with the First Appellate Authority (hereinafter called FAA) on 07.01.2022 and Second Appeal was filed in the Commission on 04.03.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter called RTI Act). Notice of hearing was issued to the parties for today i.e. 19.05.2022.

2. The appellant submits that he has not received the complete information in this case. However, the representative of the respondent submits that the information as per record has already been supplied to the appellant pertaining to the Point No. 1 to 6 of the RTI application. After going through the reply filed by the respondent, the respondent-Public Information Officer is directed to reconsider the reply filed by him pertaining to Point No. 7 & 8 of the RTI application of the appellant and file the same afresh. Regarding Point No. 9 of the RTI application of the appellant, the Public Information Officer-cum-System Manager, o/o Director, Administrative Reforms Department as the said point has been transferred to the said Public Information Officer under Section 6(3) of the RTI Act, 2005. However, the appellant further contended that the respondent has not replied as per the official record and there are ambiguities. After discussion with both the parties pertaining to first three points of the RTI application, it has ascertained that the matter can only be resolved once both the parties are present, in person. Also, the appellant submits that he wants to file the point wise rejoinder regarding the sought information. Accordingly, the appellant is directed to file the point wise deficiencies specifically, in this case, before the next date of hearing to the respondent-Public Information Officer with a copy to the Commission. Also, the respondent Public Information Officer is directed to remain present on the next date of hearing and in case of compelling circumstances he may depute the person who is well conversant with the facts of the case.

2. The appellant submits that he has received the complete information except a copy of Intkal No. 1877 pertaining to year 2010 has not been supplied. Video Conference Facility was introduced for the convenience of general public and for government officials. Viewing the attitude in dealing with the RTI application by the respondent casually, Sh. been delay in providing the information. Appellant had also suffered financial loss in getting the information. There are systemic deficiencies in the manner of receiving and disposing of applications. The department still does not appear to be properly tuned to the performance of its obligations enshrined under the RTI Act.

5. I am, therefore, of the view that ends of justice would be met by awarding a sum of Rs. 10,000/- (Rupees ten thousands only) by way of compensation to the Appellant. This amount shall be payable from the State Exchequer before the next date of hearing.

6. Sh. Dharminder Singh, Estate Officer is also directed to remain present on the next date of hearing with the requisite information pertaining to Point No.1 of the RTI application i.e. name of the allottee and plot number along with the original record for the inspection of the appellant i.e. Point No. 3 of the RTI application. It is also clarified that address of the allottee is not to be given as the same is the personal information which is exempted under the provisions of the RTI Act, 2005. He is also given an opportunity to file the reply regarding show cause notice issued to him failing which the decision will be taken on the same ex-parte, on merit.
