## ORDER

This order may be read with reference to the previous order dated 23.8.2022.

2. The appellant has sought the following information as per his RTI application:-

4. The representative of the respondents submits that the information regarding Point No. 1 of the RTI application has already been supplied to the appellant. He further submits that a copy of the names of School Management Committee will again be supplied to the appellant within a week. With regard to the remaining balance sheets, she submits that no other balance sheet is available on record which could be supplied to the appellant. She further submits that an undertaking in this regard will also be sent to the appellant within a week.

5. According to the assurance given by the respondent, the Commission is of the view that no further action is required to be taken in this case. Hence, the case is disposed of and closed. However, the appellant is at liberty to approach the Commission within two weeks in case he does not receive the same.

Sita Ram, SDO, Punjab Sewerage Board, Abohar because of non-submission of information within the stipulated period. The certified copy of the order passed in complaint No.234/2009 is required.
- (ii) Please confirm whether amount of penalty of Rs.5000/- had been recovered from the said Sh. Sita Ram and deposited in the treasury. Please supply the certified information i.e. proof of having deposited the amount of penalty in the treasury account. If the penalty has not been recovered, the reasons therefor and the action taken by the Hon'ble Commission in recovering the amount.

3. The appellant is absent without intimation. However, the specific reply has already been filed by the respondent and a copy of the same has already been sent to the appellant.

4. The reply filed by the respondent is accepted as per the provisions of the RTI act, 2005. Therefore, the Commission is of the view that no further directions can be given to the respondent. However, a copy of this order along with the case file is **being sent** to the Deputy Registrar to take up the issue with the concerned department regarding the compliance of order dated 8.9.2009 in Appeal Case No. 234 of 2009. He is also directed that proper record be maintained to ensure the compliance of cases where the penalty has been imposed or compensation has been awarded in favour of the appellant.

5. Accordingly, the case is disposed of and closed.

## ORDER

The RTI application is dated 5.5.2022 vide which the appellant has sought information as enumerated in his RTI application. 3. The appellant is absent but he has sent the written submissions in this case, which are taken on record.
