**ORDER**

The appellant alleged that he has filed two other appeal cases in the Commission bearing appeal case numbers 398 of 2022 and 5437 of 2021, which were disposed of & closed by the Commission wherein the information was provided; respondent PIO which is about to be impleaded and the information was concerned with the Himalaya Modern Senior Secondary School, Jail road, Village Babowal, District Gurdaspur and DEO (SE), Gurdaspur was party in the said cases and the information was provided to him.

It shows malafide of the school and as well as the conduct of the school shows that the school is violating the provisions of RTI Act, 2005 i.e. law of the land and it is not fair and sustainable in the eyes of law.
- 6. The DEO (SE), Gurdaspur is directed to verify this issue why school is having double standard stand for providing the information and legal action be taken against the said school, if required.
- 7. A copy of this order along with RTI application is **being sent** to the Principal Himalaya Modern Senior Secondary School, Jail road, Village Babowal, District Gurdaspur with directions to represent this case on the next date of hearing to take the matter to its logical end.
