## <u>ORDER</u>

1. The RTI application is dated 25.04.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 26.08.2022 and the second appeal was filed in the Commission on 11.07.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).

2. The notice of hearing was issued to the parties for 20.09.2022. Accordingly, the case has been heard today. Shri Gulshan Kumar comes present to attend the hearing in person before the Bench on behalf of the appellant and also produces before the Bench authority letter dated 20.09.2022 to represent the appellant before the Bench.

3. Neither the PIO O/o GLADA,Ludhiana has come present to attend the hearing in person before the Bench nor through cisco webex nor he has deputed any of his representative to attend the hearing on his behalf. The PIO has absented himself in spite of registered notice sent by the Commission and has also not provided information to the appellant. This indifferent attitude of the PIO is viewed adversely.

4. The PIO O/o GLADA, Ludhiana is issued show cause notice to explain his absence and as to why action should not be taken against him and also as to why penalty should not be imposed in the instant case for failing to appear for the hearing and for not supplying requisite information to the appellant. He is also directed to file a written reply to the show cause notice as to why the appellant should not be compensated for the mental harassment suffered by him in getting the information. Cont..P-2

5. In addition to the written reply, the PIO is hereby given an opportunity u/s 20(1) proviso thereto for personal hearing before the imposition of such a penalty, on the next date of hearing. He may take note that in case he does not file the written reply and does not avail himself of the opportunity of personal hearing on the next date fixed, it will be presumed that he has nothing to say and the Commission shall proceed to take further proceedings against him ex-parte.

6. The PIO is directed to supply requisite information to the appellant before the next hearing as also ensure to come present in person before the Bench, failing which, the Bench will be constrained to issue bailable warrant to ensure his presence before the Bench.

7. With the aforesaid directions, the matter is adjourned. To come up for hearing on **31.10.2022 at 11.30 AM in Commission's office at Chandigarh.** Copies of the order be sent to the concerned parties.
