ORDER:

1. The RTI application is dated 31.08.2021 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 09.03.2022 and the second appeal was filed in the Commission on 15.07.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).
2. The notice of hearing was issued to the parties for 20.09.2022. Accordingly, the case has been heard today.
3. Shri Manpreet Singh, Sr. XEN, P&M Division, Jamsheer, District Jalandhar comes present to attend the hearing in person before the Bench. He states that the appellant was supplied information vide letter dated 24.09.2021 and the information has been again sent to the appellant vide letter dated 14.09.2022 with a copy to the Hon'ble Commission. He further states that the appellant had filed an appeal against the final assessment regarding penalty of Rs.89699/- imposed and vide order passed by the Appellate Authority of PCTCL, it was upheld and copy of order was provided to the appellant. The appellant was also sent letter dated 05.02.2022 explaining the position in this regard and was informed that his representation made to the Chief Minister, Punjab was received at Sub Division, PSTCL, Jadla, District Nawanshahar and has been addressed and filed.
4. The appellant states that he is aggrieved by the assessment order vide which the above penalty alleging un-authorized use of power was imposed on him. He had sent a representation to the Chief

Minister in this regard requesting for cancellation of this final assessment order issued by Assistant Engineer/ Assessing Officer, Sub Division, Jadla, PSTCL, Nawanshahar by getting the matter looked into and that action was required to be taken by the Chairman & Managing Director, PSTCL. He alleges that his representation has not been dealt with at appropriate level and his grievance is still unaddressed. He insists that the action on his complaint should have been taken at the level of CMD PSTCL and not at any level below him.

5. The Bench, on perusal of the reply given to the appellant and after examining the relevant documents, observes that the information has been supplied by the PIO, the receipt of which the appellant admits. The Bench further observes that the appellant has grievance for the penalty imposed on him, and so far as the information sought by the appellant is concerned, the Bench is convinced that requisite information stands supplied to the appellant. The insistence of appellant to expect the action on his representation at the level of CMD, PSTCL is not justified as the action has been taken by the subordinates of PSTCL on behalf of CMD, PSTCL.

6. With the aforesaid observations, the Bench does not feel that there is any need of further intervention in the matter and thus, is not inclined to proceed further in the matter. **The instant appeal case is disposed off and closed.** Copies of the order be sent to the concerned parties.

ORDER

1. The RTI application is dated 08.04.2021 vide which the Complainant has sought information as enumerated in her RTI application. Complaint was filed in the Commission on 15.07.2022 under Section 18 of the Right to Information Act, 2005 (hereinafter RTI Act).
2. The notice of hearing was issued to the parties for 20.09.2022. The case has been heard today. Ms. Ranjna Kukkar, complainant has not come present in person before the Bench or through cisco webex.
3. Shri Sandeep Singh, O/o Tehsildar, Jalalabad (West), District Fazilka comes present to attend the hearing in person before the Bench. He states that the record relating to the information sought by the appellant is very old and is not traceable and that efforts are being made to trace the said records for supplying the information to the complainant.
4. The Bench observes that the complainant has directly approached the Commission by preferring complaint in the Commission. The Bench further observes that the complainant has not availed the provision of Section 19(1) of the RTI Act by filing an appeal with the First Appellate Authority (FAA). As such, the FAA has not been able to address the grievances of the complainant. The attention of the Complainant is drawn to the decision of the judgment of Hon'ble Supreme Court of India rendered on 12.12.2011 in Information Commissioner and another Versus State of Manipur and another in para 31 whereof, it has been held that while entertaining a complaint case under Section 18 of the RTI Act, 2005, the Commissioners

have no jurisdiction to pass an order providing for an access to the information which is as under:-

31. We uphold the said contention and do not find any error in the impugned judgment of the Hon'ble High Court whereby it has been held that the Commissioner while entertaining a complaint under Section 18 of the said Act has no jurisdiction to pass an order providing for access to the information."

As such, since the complainant has approached the Commission under the provisions of Section 18 of the RTI, 2005, no directions for providing further information can be given by the Commission.

5. Since there is an alternative and efficacious remedy of First Appeal available to the Complainant under Section 19(1) of the RTI Act, 2005 which has not been availed in the instant complaint case and the First Appellate Authority has not had the occasion to review the decision of PIO, as envisaged under the RTI Act by passing a detailed well reasoned speaking order.

6. The instant matter is remanded back to the **First Appellate Authority i.e. Shri Ravinder Singh, Sub Divisional Magistrate, Fazilka**. The Commission hereby directs the FAA to treat the copy of the Complaint (enclosed herewith) as the First Appeal and decide the matter in accordance with the provisions of the RTI Act after giving all concerned parties an opportunity to be heard. He is directed to hear the complainant within ten days and decide the matter.

7. In case, the complainant is not satisfied with the decision of the First Appellate Authority (FAA), she is at liberty to file second appeal before Punjab State Information Commission Section 19(3) of the RTI Act, 2005.

8. In view of the above, **the case is disposed off and closed**. Copy of the order be sent to the parties.
