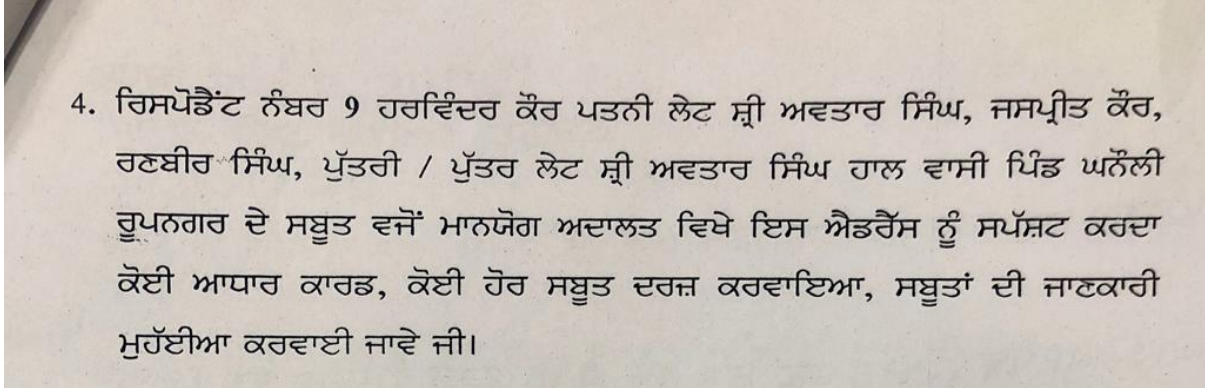

4. ਰਿਸਪੋਂਡੈਂਟ ਨੰਬਰ 9 ਹਰਵਿੰਦਰ ਕੌਰ ਪਤਨੀ ਲੇਟ ਸ਼੍ਰੀ ਅਵਤਾਰ ਸਿੰਘ, ਜਸਪ੍ਰੀਤ ਕੌਰ, ਰਣਬੀਰ ਸਿੰਘ, ਪੁੱਤਰੀ / ਪੁੱਤਰ ਲੇਟ ਸ਼੍ਰੀ ਅਵਤਾਰ ਸਿੰਘ ਹਾਲ ਵਾਸੀ ਪਿੰਡ ਘਨੌਲੀ ਰੂਪਨਗਰ ਦੇ ਸਬੂਤ ਵਜੋਂ ਮਾਨਯੋਗ ਅਦਾਲਤ ਵਿਖੇ ਇਸ ਐਡਰੈੱਸ ਨੂੰ ਸਪੱਸ਼ਟ ਕਰਦਾ ਕੋਈ ਆਧਾਰ ਕਾਰਡ, ਕੋਈ ਹੋਰ ਸਬੂਤ ਦਰਜ ਕਰਵਾਇਆ, ਸਬੂਤਾਂ ਦੀ ਜਾਣਕਾਰੀ ਮੁਹੱਈਆ ਕਰਵਾਈ ਜਾਵੇ ਜੀ।

3. The representative of the respondents states that the appellant has already informed that the sought information is not available on record and as per the record keeper of Judicial Record Room under the Control of Civil Judge (Sr. Divn.), Rupnagar, he has submitted his report i.e. "as per report case titled Gurdev Kaur Vs Jasmer Singh Case No. 56289 of 2013 decided on 31.5.2016 decided by Ms. Paramjit Kaur, Civil Judge (Sr. Divn.), Rupnagar required documents not found in the said file". She further states that there is also a provision for the applicants that he may inspect the record by filing the fresh application. In addition, she also states that the said information has already been provided to him vide letter dated 27.10.2020 but no deficiency/submissions have been received from him. Accordingly, the representative of the respondents requests for the closure of the case.

4. After going through the facts of the case and record of the case file, it has transpired that the appellant has not appeared before the First Appellate Authority even though he has been called twice. Today the appellant remained absent without intimation. Even the information was supplied to the appellant along with the orders of the Commission but neither he has made any submissions nor he has pointed out any deficiency in the information so supplied by the respondents. Therefore the ex-parte decision is being taken and the Commission is of the view that no further action is required in this case. Hence, the case is disposed of and closed.

## ORDER

The RTI application is dated 9.6.2020 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter called FAA) on 24.7.2020 and second appeal was filed in the Commission on 11.9.2020 under Section 19 of the Right to Information Act, 2005 (hereinafter called RTI Act). Notice of hearing was issued to the parties for today.

2. The appellant has sought the following information:-

2. ਜੋ ਸੀਵਰੇਜ ਤੇ 35 ਲੱਖ ਰੁਪਏ ਖਰਚ ਕੀਤਾ ਉਸਦਾ ਹਿਸਾਬ ਦਿੱਤਾ ਜਾਵੇ।”

3. The appellant states that no information has been provided by the respondents so far. However, the representative of the respondents states that no grant has been spent by the present Panchayat with regard to the information sought by the appellant. He has also handed over the written submissions in this regard with which the appellant is satisfied. After receiving the response from the respondents, the appellant states that he has no objection in case his case is disposed of.

4. According to the submissions of the appellant, no further action is required in this case. Hence, the case is disposed of and closed.

## ORDER

The RTI application is dated 9.6.2020 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter called FAA) on 24.7.2020 and second appeal was filed in the Commission on 11.9.2020 under Section 19 of the Right to Information Act, 2005 (hereinafter called RTI Act). Notice of hearing was issued to the parties for today.

2. The appellant has sought the following information:-

- 3) ਪਿੰਡ ਵਾਸੀਆਂ ਨੂੰ ਭਰੋਸੇ ਵਿੱਚ ਲੈ ਕੇ ਜੇਹੜੀ ਵੀਡੀਓ ਬਣਾਈ ਸੀ ਉਸਦੀ ਕਾਪੀ ਦਿੱਤੀ ਜਾਵੇ।”

2. The appellant states that no information has been provided by the respondents so far. However, the representative of the respondents states that he has brought the information along and the same has been handed over to the appellant during the course of hearing regarding Point No. 1 and 2 of the RTI application. With regard to the Point No. 3 of the RTI application, the representative of the respondents states that no videography has been made and the same has been written specifically. After going through the same the appellant shows his satisfaction over the provided information and states that he has no objection in case his case is closed.

3. According to the submissions of the appellant, the Commission observes that no further action is required in this case. Hence, the case is disposed of and closed.
