ORDER

1. This order may be read with the reference of the previous order dated 12.10.2022 vide which respondent stated that record was inspected by the appellant and he is satisfied with the same. He added that appellant has given an acknowledgement for the same dated 07.06.2022 and copy of the same will be sent to the Commission by today for sure. He further mentioned that nothing has been pointed out till date, even after a lapse of two months by the appellant.

Respondent PIO was directed to send acknowledgments signed by the appellant to the Commission today itself and matter was adjourned for further hearing on 20.12.2022.

2. In today's hearing, the appellant states that the inspection has been conducted by him and respondent assured that he will supply the identified pages but not supplied by him.
