It be further stated that nothing has been concealed therein and the statement made is true and correct and produce the same before the Bench, on the next date of hearing, failing which action will be initiated against him/her as per provisions of the RTI Act, 2005.

4. The matter is adjourned. To come up for hearing on **20.03.2023 at 11:30 AM in the Commission.** Both the parties are directed to present their case personally.
