2. Both parties are present. At the last Hearing on 07.05.2024, a Show Cause Notice was issued to the Motor Vehicle Inspector O/o RTO Amritsar as well as the Secretary RTA, Amritsar. The Secretary, RTA, Amritsar has submitted, a reply vide Letter No. 3026 Dated 17.05.2024. It is taken on record. The PIO-cum-MVI O/o RTO, Amritsar, has submitted a separate reply vide Letter No. 3027 Dated 17.05.2024, wherein he states that the record sought in this RTI application was traced in the record room in the O/o Secretary, RTA, Amritsar and it was found to be damaged by termites and not in a state to be copied and provided to the appellant. The PIO, represented by Sh. Jatinder Singh, Junior Assistant, has brought the original register to this Hearing. He has also submitted photographs of the record room located in the Punjab Roadways Workshop at Amritsar and the same have been provided to the appellant Sh. Manjinder Singh. 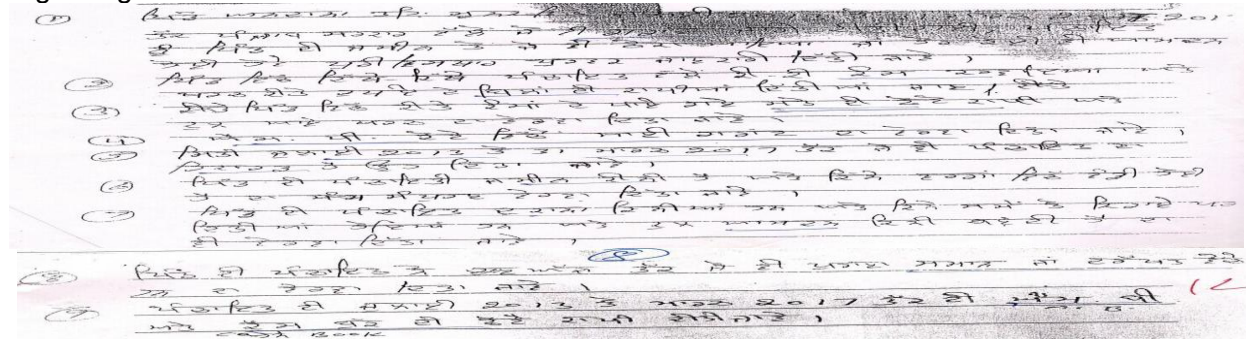
