as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **12.06.23** and Second Appeal was filed in the Commission on **28.07.2023** under Section 19 of the Right to Information Act, 2005. This case was last heard on **23.2.2024**.

2. This case was reserved for final orders on 23.2.2024. Prior to this a Show Cause Notice was issued to the PIO, office of, Deputy Commissioner, Tarn Taran, vide this Commission's Order of 27.10.2023. The PIO-cum-DRO, has submitted a reply to the said Show Cause Notice vide Letter No. 763 Dated 26.5.2024, wherein he states that, the RTI application was received online on 21.4.2023, and the same was duly transferred to the District Education Officer (Elementary)-cum-PIO vide Letter No. 1096 Dated 2.5.2023. Thereafter, the DEO (Elementary) supplied the information to the appellant vide Letter No. 3/2023/276349 Dated 3.10.2023. The PIO-cum-DRO, contends that any delay is not attributable to his office.

3. Keeping in view the facts and circumstances that are evident from the correspondence submitted by the PIO-cum-DRO, the Commission hereby withdraws the Show Cause Notice. There is no further cause for action and the Appeal is **Disposed of**.

1. The RTI application is dated **22.05.2023** vide which the appellant has sought information regarding:

as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **14.06.2023** and Second Appeal was filed in the Commission on **07.08.2023** under Section 19 of the Right to Information Act, 2005. The case was last heard on **1.3.2024**.

2. This case was reserved for final orders on 1.3.2024, whereon the appellant stated that, he had filed this RTI application on behalf of his father and that he himself had little knowledge of facts of the case. He was provided the Landline Number of this Bench and advised to ask his father or someone more familiar with the case to inform the Commission whether the information provided by the PIO vide Letter No. 5640-41 Dated 18.7.2023, by Registered Post was satisfactory or not.

3. The appellant Sh. Amandeep Singh, has not communicated anything to the Commission since the last Hearing on 1.3.2024, this compels the conclusion that, he is satisfied with the information provided. There is no further cause for action and the Appeal is **Disposed of**.
