# Appeal Case No. 3331 of 2020 (Video Conference Proceedings)

### PRESENT:

#### ORDER:

(To be read in continuity with earlier orders on 3.3.2021, 7.7.2021, 9.12.2021, 6.4.2022, 23.6.2022, and 18.8.2022)

- 1. The RTI application is dated **17.7.2020** vide which the appellant has sought information regarding a colony, DD Chandigarh Enclave being promoted by one Jatinder Kumar s/o Yashpal at Husner Road Gidderbaha, in four points, as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **31.8.2020**, and Second Appeal was filed in the Commission on **2.11.2020** under Section 19 of the Right to Information Act, 2005. The case was last heard on **18.8.2022**.
- 2. Both parties are present. The appellant represented by Prince Goyal Advocate, is present in person. At the hearing on 23.6.2022, the respondent PIO was directed to be present in person at the Commission on 18.8.2022, along with complete original file pertaining to the housing project colony, DD Chandigarh Enclave being promoted by one Jatinder Kumar s/o Yashpal at Husner Road Gidderbaha. However, the hearing on 18.8.2022 was adjourned because of inability of the appellant to attend the same.
- 3. The PIO-cum-EO, Sh. Vishal, is hereby directed to be present in person along with complete original file regarding the housing project DD Chandigarh Enclave promoted by one Jatinder Kumar s/o Yashpal at Husner Road Gidderbaha, at the Commission on Friday, 30.9.2022 afternoon. The PIO-cum-EO, can also depute any subordinate officer with adequate knowledge of the requested, record to be present in person during the aforesaid hearing at the Commission.
- 4. Next hearing on 30.9.2022 at 11.30 am at Punjab State Information Commission, Red Cross Building, Sector- 16, Chandigarh.
