Singh, Superintendent Education – 4 branch, who has already made the written submissions that the said letter has never received in his office and appropriate action in the RTI application has to be taken by Education –7 Branch. Sh. Surjit Singh, Superintendent Education – 4 Branch further requested to withdraw the show-cause notice isued to him. The decision regarding show-cause notice issued to Sh. Surjit Singh will be taken on the next date of hearing.

- 4. Since, the RTI application of the appellant has already been transferrred to the Director, Public Instructions (E.E.), therefore, Public Information Officer of the said office is directed to file a reply/supply the information in this case before the next date of hearing.
- 5. Viewing the attitude in dealing with the RTI application by the respondent in a casual manner, Ms. Bindu, Assistant Director-cum-Public Information Officer, is, thus, issued a show cause notice to explain in a self-attested affidavit as to why a penalty @ Rs.250/- per day of delay subject to a maximum of Rs.25,000/- till the complete information is furnished, be not imposed under Section 20(1) of RTI Act, 2005 on her for causing willful delay/denial of the information to the RTI applicant and to show cause why a compensation under section 19(8) of the RTI Act,2005, may not be paid to the appellant for causing willful delay/denial of the information for detriment suffered by him.

In addition to the written reply, the Public Information Officer is also given an opportunity under Section 20(1) proviso thereto, for a personal hearing before the imposition of such penalty on the next date of hearing. She may take a note that in case she does not file her written reply and does not avail herself of the opportunity of personal hearing on the next date, it will be presumed that she has nothing to say and the Commission will proceed ex-parte.

- 6. Also a copy of this order **is being** sent to the Director, Public Instructions (Elem.) Punjab, S.A.S. Nagar (Mohali) to fix the responsibility for non-appearance of the PIO in this case and action taken in this regard be sent to the Commission.
- 7. With this, the case is adjourned to 5th June, 2024 at 11:30 A. M. for hearing.
