Shri Piara Singh, appellant filed RTI application dated 06.11.2020 and sought some information from the SPIO, O/o BDPO, Dera Baba Nanak, Distt. Gurdaspur.

Shri Rajinder Singh, son of Shri Piara Singh is personally present on his behalf, whereas the respondent SPIO is absent.

I have gone through the order dated 07.12.2021 and as no information was provided to the appellant, so an amount of Rs.5,000/- was awarded in favour of the appellant to be paid by the SPIO from the funds of public authority by way of demand draft. But the SPIO has not complied with the Order of the Commission.

So, the SPIO is directed that the attested copies of sought for information be provided to the appellant within 10 days along with the amount of compensation of Rs.5,000/-from the funds of public authority by way of demand draft and compliance be sent to the Commission accordingly.

As the appellant has filed RTI application on 06.11.2020 and a period of more than one year has been passed, but the SPIO has not provided the information to the appellant. It shows that the SPIO has no respect for the law and the Commission and his conduct amounts to denial of information and defiance of the provisions of the RTI Act, 2005. So, a **show cause notice** is issued to **Shri Iqbal Singh**, **PIO-cum-Panchayat Secretary**, **Gram Panchayat**, **Dehar** that why the sought for information has not been provided to the applicant till date and so why he may not be penalized up to Rs.25,000/-.

The SPIO is directed to file reply to the show cause notice in writing and send the same to the Commission at least 10 days before the next date of hearing and an opportunity of personal hearing will be afforded to him on the show cause notice. In case the SPIO would not file reply to the show cause notice then it will be assumed that he do not want to say anything in his defense and the show cause notice will be decided without hearing him and a penalty of Rs.25,000/- will be imposed upon him.
