APPEAL CASE NO. 4065 OF 2022

4. In view of the above, the PIO O/o Deputy Chief Executive Officer, District Parishad, Moga is impleaded as Respondent No. 2 in this case and the PIO is further directed to supply available information to the appellant.

5. The PIO O/o Director, Rural Development & Panchayat Department, Punjab is also directed to retrieve the requisite information from the concerned office and supply to the appellant, before the next date of hearing.

6. Both the above said PIOs are directed to provide the requisite information/reply to the appellant, before the next date of hearing and should appear personally through Cisco Webex, on the next date of hearing, failing which **BAILABLE WARRANT** will be issued to both of them.

7. The matter is adjourned. To come up for hearing on **03.04.2023 at 11:00 AM through CISCO WEBEX MEETING ID No. 158 188 4645**. Both the parties are directed to present their case accordingly. Copies of the order be sent to the parties.
