- 1. The RTI application is dated 23.04.2022 vide which the appellant has sought information regarding: "Copy of bills of Water Supply and Sanitation Committee, New Rajguru Nagar pertaining to year 01.10.2021 to 20.04.2022 etc.," as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on 03.06.2022 and Second Appeal was filed in the Commission on 16.05.2023 under Section 19 of the Right to Information Act, 2005. The case was last heard on 1.12.2023.
