- 2. The appellant has sent an email along with the applications addressed to the officers shown in his RTI application and order dated 1.6.2022 passed by FAA in this case. The appellant states that the PIO has not provided the information pertaining to his applications dated 25.2.2020 after receiving and before receiving his applications despite the order passed by FAA to supply the information within 10 working days. The email so received is taken on record.
- 3. The APIO states that the information has been sent to the appellant. A copy of the same has been sent to the Commission which is taken on record. The representative of the PIO submits the file before the Commission for perusal.
- 4. After hearing both the parties and perusal of the reply and file of the respondents, the Commission does not accept the reply of the PIO. The appellant has sought the status and action taken on his applications dated 25.2.2022 addressed to the officers as shown above but the PIO has provided irrelevant reply and file submitted before the Commission has no relevant documents. It is also observed that there is ambiguity in the sought information as the appellant has sought information status of his "applications before receiving application". Therefore, the contention to provide status of his applications before submission is not accepted by the Commission.
- 5. Viewing the attitude in dealing with the RTI application by the respondent in a casual manner, Sh. Nirbay Singh, Asst. Secretary cum Asstt. Public Information Officer and Sh. Rajnish Sharma, Asstt. Publication Officer(Allotment), are, thus, issued a show cause notice to explain in a self-attested affidavit as to why a penalty @ Rs.250/- per day of delay subject to a maximum of Rs.25000/- till the complete information is furnished, be not imposed under Section 20(1) of RTI Act, 2005 on him for causing wilful delay/denial of the information to the RTI applicant and to show cause why a compensation under section 19(8) of the RTI Act,2005, may not be paid to the appellant for causing wilful delay/denial of the information for detriment suffered by him.

In addition to the written reply, the above said officers are also given an opportunity under Section 20(1) proviso thereto, for a personal hearing before the imposition of such penalty on the next date of hearing. They may take a note that in case they do not file written reply and do not avail themselves of the opportunity of personal hearing on the next date, it will be presumed that they have nothing to say and the Commission will proceed ex-parte.

- 6. Keeping in view of the above, the applications dated 25.2.2020 **are sent** along with the order with the direction to the PIO/ APIO to file response/ supply status of applications dated 25.2.2020 of the appellant after receiving applications of the appellant before the next date of hearing and bring the original concerned file on the next date of hearing.
- 7. To come up on 21.10.2022 at 12.30 P.M. to be heard through video conference facility available in the office of the Deputy Commissioner, Jalandhar for the appellant and at Chandigarh for the respondents.
