1. This order may be read with reference to the order dated 03.03.2020 passed by the Bench on the previous hearing.
2. Ms. Sukhjinder Kaur, Advocate attends hearing through V.C. on behalf of the appellant. 5. Appellant is advised to visit the office of PIO to peruse the official records to identify the information required as per RTI application and the PIO is directed to provide the copies of documents so identified by the appellant. It was made clear during previous hearing that information regarding the enquiry referred to above at whatever stage the enquiry exists at present, be provided to the appellant and any part of the same which is apprehended to affect the outcome of the enquiry, may be withheld.
