

2. Sh Gurpreet Singh Lapran the complainant had sought information vide his RTI application dated 09.03.2020, which is as under:-

- 3. No one has appeared on behalf of the Respondent today. However, a reply in response to the show cause notice has been received from him vide Commission diary no. 10469 dated 24.08.2020 mentioning therein that the information sought by the complainant is in question/Query form, and as such, no answers to Questions/Queries are to be given under the RTI Act. Further, the Respondent also adds that no information pertaining to the RTI of the complainant is available in their official record. Copy of the reply is taken on record. Keeping in view all the facts mentioned in the reply the show cause notice is ,hereby, is dropped.
- 4. The perusal of the file ascertains that the information sought by the complainant is in Question/answer form, which is not to be answered under the RTI Act.

"Central Information Commission vide order dated 21.04.2006 in case no. CIC/AT/A/2006/00045 has decided that -

(The RTI Act does not cast on the public authority any obligation to answer queries, as in this case, in which a petitioner attempts to elicit answers to his questions with prefixes, such as, why, what, when and whether. The petitioner's right extends only to seeking information as defined in Section 2 (f) either by pinpointing the file, document, paper or record, etc., or by mentioning the type of information as may be available with the specified public authority.)"

- 5. Moreover, this is the complainant case and the complainant has approached the Commission under the provision of Section 18 of the RTI Act, 2005, no directions for providing further information can be given by the Commission.
