## ORDER

The RTI application is dated 23.5.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter called FAA) on 12.8.2022 and second appeal was filed in the Commission on 18.8.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter called RTI Act). Notice of hearing was issued to the parties for today.

2. The appellant submits that the directions may be issued to the respondent-Public Information Officer to supply the complete information. Furthermore, for the convenience of the appellant, he submits that Ms RajniBala, Sr. Asstt may be contacted for the inspection. The respondent has also placed on record the information so supplied to the appellant.
