ORDER:

The appellant through RTI application dated 05.02.2020 has sought information regarding benefit of proficiency/4 years ACP provided to EO Improvement Trusts in the year 2011 or thereafter – noting portion/correspondence done on the order dated 24.06.2019, 21.10.2019, 15.11.2019 sent to the appellant and other information as enumerated in the RTI application concerning the office of Deputy Secretary Local Govt. Pb Chandigarh. The appellant was not satisfied with the reply of the PIO dated 09.03.2020 vide which the appellant was asked to specify the information after which the appellant filed a first appeal before the First Appellate Authority on 18.05.2020 which took no decision on the appeal.
