- 3. <u>Post Deliberation:</u> In the view of above, the matter is adjourned to the personal hearing at PSIC, Chandigarh on 27th, June, 2022 at 12.00 P.M with the directions to the respondent PIO to bring the whole relevant office record pertaining to this case in the Commission on the next date of hearing. In case the partial information is not available in the office record then an affidavit may be filled in this regard to the appellant with a copy to the Commission.
