**ORDER:**

The complainant through RTI application dated 23.07.2019 has sought information regarding power connection No.AP-34/2755(7.1/2 BHP) Bhagwan Singh s/o Atma Singh of Zira and other information concerning the office of SDO PSPCL Zira. The complainant was not provided the information after which the complainant filed a complaint in the Commission on 04.09.2019.

The case was first heard on 06.01.2020. Both the parties were absent. The case was adjourned.

The case was last heard on **27.01.2020**. The counsel appeared on behalf of the complainant informed that the PIO has not provided the information. The respondent was absent on 2<sup>nd</sup> consecutive hearing. The Commission observed that the complainant has filed RTI application on 23.07.2019 but has not gone to the First Appellate Authority. The Commission remanded back the case to First Appellate Authority with the direction to hear the case and dispose off the appeal within 30 days.

The Commission further observes that there has been an enormous delay of six months in attending to the RTI application by the PIO. The PIO was issued a **show cause notice under Section 20 of the RTI Act 2005 and directed to file reply on an affidavit.**

Sh.Santokh Singh, AE O/o PSPCL Zira appeared late and informed that the information has been sent to the complainant. He was informed that the case stands adjourned.

The respondent present pleaded that the information was sent to the complainant vide letter dated 09.09.2019 but the same was received back due to incomplete address. The appellant is absent. The appellant is directed to contact the PIO and provide the correct address as well as collect the information.

**ORDER:**
