It is surprising matter that a period of five years has passed but the department has not prepared the Fard Jamabandi for the year 2013-14, whereas as per the law Jamabandi for the year 2018-19 should be in process in these days.

So, the PIO-cum-Deputy Commissioner, SBS Nagar should take notice of the above said fact that Fard Jamabandi for the year 2013-14 has not been prepared till now.

As the information has been sent to the appellant vide letter no. 106 dated 21.06.2019, so no cause of action arose in the present appeal case as the matter has been reported to the appellant by the Tehsildar regarding the errors in the revenue record.
