The respondent-PIO is directed to take appropriate action on RTI application of the complainant under the provisions of the RTI Act, 2005, in case any information is not available on the website and give specific reply to the complainant, whether the information can be supplied or not. On receipt of the reply from the respondent-PIO, the complainant is advised to go through the same and revert back to the authorities, in case of deficiencies as early as possible and respondent-PIO is further directed to remove the deficiencies on its receipt from the complainant.
- 5. The case is adjourned to 18.11.2019 at 3.30 P.M. to be heard through Video Conference Facility available in the office of the Deputy Commissioner, Patiala.
