Shri Jagshir Singh, appellant filed RTI application dated 18.08.2018 and sought some information from the office of the SPIO.

Today the case is heard through CISCO Webex Meetings Software.

Shri Jagshir Singh, appellant is present, but none has come present on behalf of the SPIO. The appellant stated that the complete information has not been provided to him by the SPIO neither the amount of compensation of Rs.10,000/- has been paid to him by the SPIO.

The appellant has filed RTI application on 18.08.2020 and a period of more than two years has been passed, but incomplete information has been provided to him by the SPIO. The SPIO is absent today. He was also absent on 01.07.2020, 22.07.2020, 11.08.2020, 15.10.2020 and today again he is absent.

A Show Cause Notice was issued to the SPIO vide Order dated 17.07.2019 passed by the Commission.

I have gone through the Order dated 15.10.2020 and a last and final opportunity was granted to Shri Parminder Singh, SPIO-cum-BDPO, Ghal Khurd and Shri Nirmaljit Singh, SPIO-cum-Panchayat Secretary, Gram Panchayat, Ratta Khera Punjab Singh to file reply to the Show Cause Notice. But they are absent today and neither they have filed reply to the Show Cause Notice.

Shri Parminder Singh, BDPO, Ghal Khurd being administrative head of the office has failed to perform his duties willfully and being deemed SPIO he is also responsible for not providing the complete information to the appellant.

Appeal Case No. 3889 of 2018

So I impose a penalty of Rs.12,500/- upon Shri Parminder Singh, SPIO-cum-BDPO, Ghal Khurd and a penalty of Rs.12,500/- upon Shri Nirmaljit Singh, SPIO-cum-Panchayat Secretary, Gram Panchayat, Ratta Khera Punjab Singh and the amount of penalty be deducted from the salaries of concerned persons and be deposited in the Government Treasury in the following heads and compliance report be sent back to the Commission before the next date of hearing :-

"Major Head	0070-Other Administrative Services
Sub Major Head	60-Other Services
Minor Head	800-Other Receipts
Sub Head	86-Right to Information Act, 2005."

The SPIO is directed to send the attested copies of remaining sought for information to the appellant along with demand draft of Rs.10,000/- as compensation from the funds of public authority by way of demand draft through registered post within 10 days and send compliance report to the Commission accordingly.

A copy of Order be sent to the District Development and Panchayat Officer, Ferozepur for strict compliance of the Order of the Commission.
