1. The RTI application is dated 07.02.2023 vide which the appellant has sought information regarding **“Show cause notice issued to Sh. Narinder Singh Ex-State Secretary and final enquiry report against Sh. Narinder Singh Ex-State Chief Commissioner etc., ,”** as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on 10.03.2023 and Second Appeal was filed in the Commission on 26.04.2023 under Section 19 of the Right to Information Act, 2005. This case was last heard on 08.12.2023.

2 . Both the parties are present. Respondent PIO represented by Sh. Harinder Sharma (Deputy Secretary) has supplied a copy of the report of the five member committee and a copy of the complaint Letter to the SHO Sector-11, Chandigarh, Dated 20.10.2020. The PIO is hereby, directed to provide a clear reply to the following:

i). Whether the appointment of the State Chief Commissioner, the Bharat Scouts and Guides, Punjab, Sh. Sukhbir Singh Bal was made on the basis of notification. If yes, the appellant be provided a copy of the notifications. If no such notification was issued to Mr. Bal's appointment as State Chief Commissioner, the PIO is to inform the appellant in writing that Sh. Bal's appointment was made only on the basis of the proceedings of the State Executive Committee of Bharat Scouts and Guides, Punjab, meeting of 23.07.2022 which have already been provided to him.

(To be read in continuity with earlier orders on 21.04.2023, 22.05.2023, 28.07.2023, 02.11.2023 and 08.12.2023)

1. The RTI application is dated 30.09.2022 vide which the appellant has sought information in regarding **“expenditure incurred on web channel ads, electronic media, radio ads and Google/Youtube etc.”** as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on 02.11.2022 and Second Appeal was filed in the Commission on 17.02.2023 under Section 19 of the Right to Information Act, 2005. This case was last heard on 08.12.2023.

2. Appellant is absent. The respondent PIO has submitted a fresh reply to the RTI application vide Letter No. 1/809630/2024 Dated 22.03.2024. The PIO's reply to point No. 2 which is as under :
