I have heard the appellant as well as the PIO. The appellant stated that she is satisfied with the information provided to her except para no. 4, 7 and 13 of the RTI application and the PIO was directed that information regarding para no. 4, 7 and 13 of the RTI application be clarified that which part has been provided and in case any part of the information is yet to be provided that be provided within 15 days. The conduct of the PIO amounts to denial of information and defiance of provisions of the RTI Act, 2005. So, a Show Cause Notice is issued to Smt. Pallavi Chhabra, PIO-cum-DM, Punjab State Warehousing Corporation, Kapurthala that why she has not provided the complete information to the appellant and so why you may not be penalized under the provisions of the RTI Act, 2005 and why not compensation be awarded to the appellant.

The PIO should personally come present on the next date of hearing and file reply to the Show Cause Notice and an opportunity of personal hearing will be afforded to her. In case she would not come present then it will be assumed that the PIO have no respect for the law and the matter will be referred to the Government for taking disciplinary action against the PIO. The PIO is further directed that the remaining information be provided to the appellant within 15 days.
