5.	Kindly provide the details of all expenditure done by PSIEC in lieu of the amenities mentioned in aforesaid brochure, Support your answer with certified copy of account statements, vouchers etc.

as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on 16.12.2019 and Second Appeal was filed in the Commission on 16.3.2020 under Section 19 of the Right to Information Act, 2005. The case was last heard on 18.03.2024.

2. As directed, the respondent PIO, represented by Adv. Sh. Ajay Pal Singh (Counsel for the respondent) accompanied by Sh. Preeti (ALO) and Ms. Isha (Sr. Executive) has submitted a notarized affidavit on behalf of PIO, Sh. Swaijeet Singh Brar, (Deputy General Manager, PSIEC), which is dated 27.03.2024. They have also submitted copy of a letter No. 8922- 23 Dated 21.03.2024 from the Estate officer-5, to the PIO/DGM(Legal), whereby the proposal for assigning responsibility for missing record and direction to concerned official/officials to trace/reconstruct said records have been issued. The Commission takes note of the aforesaid letter and deems it appropriate to implead the Managing Director, PSIEC, Ms. Baldeep Kaur in this appeal case and directs her to complete the aforesaid exercise, of fixing responsibility for the missing record as well as for tracing and/or reconstructing said record, within a period of 3 months. This must be done under intimation to the Appellant Sh. Gagnish Singh Khurana as well as the Commission.

3. The appeal case is accordingly, **Disposed of** with above direction.
