A copy of the same is handed over to the Appellant during the hearing and same is retained in the case file.

5. The Bench on perusal of the reply is convinced that adequate information/reply has been supplied to the appellant and the Show Cause Notice issued to the PIO is hereby withdrawn.

6. In view of the above, no cause of action is left in this case. Hence, the Appeal case filed by the appellant is **disposed off and closed**. Copy of the orders be sent to the parties.
