The SPIO though is absent today, but he has sent a mail to the Commission on 16.04.2021, diarized vide no.8585, which is a copy of letter no.961 dated 05.04.2021 along with a photocopy of postal receipt dated 05.04.2021 and attested copies of information. I have gone through letter no.961 dated 05.04.2021 vide which the attested copies of information was sent to the appellant.

As the counsel of the appellant stated that incomplete information has been sent by the SPIO, so the appellant is directed that he should submit the list of deficiencies in writing to the notice of the SPIO within 3 days and the SPIO is further directed that in case the appellant would submit the deficiencies, then the attested copies of information regarding the deficiencies be sent to the appellant through registered post within 5 days from the receipt of deficiencies and compliance be sent to the Commission accordingly. Non compliance of the Order of the Commission would be viewed seriously and action would be taken against the SPIO under the provisions of the RTI Act, 2005.
