“ That the information sought by the applicant namely Arun Garg vide RTI dated 10.02.2020 has already been provided to the applicant by this office letter no. 576 dated 02.02.2021 and then the copy of the same was forwarded to the Hon’ble State Information Commission Punjab, Chandigarh (Copy attached)

2. That Sh Inderpreet Singh, Assistant Superintendent, Central Jail, Ludhiana has informed undersigned vide letter no. 241 dated 02.02.2021 that on dated 27.06.2019 some notorious prisoners set the record on fire which was lying in the Main Chakkar during the riots and thereafter, the record related to convicts & undertrials was destroyed. Therefore information could not be traced regarding the action taken with regard to the letter no. G.I./A-8/26731-33 dated 18.12.2018 of Head Office Prisons.

3. That regarding incident occurred in Central Jail, Ludhiana on 27.06.2019 the then Superintendent, Central Jail Ludhiana sent a letter vide letter no. 5630 dated 27.06.2019 to Station House Officer, P. S Division No.07, Ludhiana for registered an FIR against the prisoners who involved in the riots (Copy attached)

4. That an Fir No. 127 dated 27.06.2019, U/s 307/353/332/186/224/436/427/148/149 IPC, P.S Division No.07, Ludhiana has been registered against the notorious prisoners (Copy attached)”
