1. The RTI application is dated **22.04.2023** vide which the appellant has sought information **regarding "32 employees sacked under enquiry by Government Officials etc.,"** as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **28.05.2023** and Second Appeal was filed in the Commission on **31.07.2023** under Section 19 of the Right to Information Act, 2005. This case was last heard on **23.02.2024**.

2. Both parties are present. As directed by the Commission in its Order Dated 23.02.2024, inspection of the concerned record was conducted by the appellant on 26.02.2024. In the same Order, the PIO was also directed to make a written submission by way of details narrated by Sh. Sanjay Kumar, Drafts Man. o/o XEN Powerhouse No. 1 and Hydrel Channel Division, Shahpur Kandi Township. He was directed to clearly state whether Oustee Certificates and Land Acquisition Notices were taken from the 32 persons cited in the RTI application, at the time of their employment in 2013. The PIO has failed to comply, but submits that the concerned office i.e. XEN Powerhouse No. 1 and Hydrel Channel Division, Shahpur Kandi Township, is not cooperating.

3. Accordingly, the Commission deems it appropriate to implead Sh. Arvind Kumar, XEN Powerhouse No. 1 and Hydrel Channel Division, Shahpur Kandi Township, as the deemed PIO in this Appeal Case and directs him to provide a written reply as per directions issued vide Para No. 3 of this Commission's Order Dated 23.02.2024. This must be done on or before the next Hearing. The PIO is also directed to be heard in person at the next Hearing.
