As directed, at the last Hearing on 28.02.2024, the PIO has submitted copy of fresh, pointwise reply to the RTI application along with the available information. The same was sent to the appellant Sh. Sandeep Kumar, vide Letter No. 11640 Dated 16.05.2024.

3. The Commission has examined the RTI application alongside the aforesaid reply, which adequately addresses the RTI application. There is no further cause for action. The appeal is accordingly, **Disposed of.**

8. If erection of fourth Flour is legitimate, kindly provide me copy of provision so that it can be erected by residents of Block Who wish to built same.

as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **22.12.2022** and Second Appeal was filed in the Commission on **08.05.2023** under Section 19 of the Right to Information Act, 2005. This case was last heard on **23.02.2024**.

2. Both parties are present. At the Hearing on 05.12.2023, the respondent PIO provided a pointwise reply to the appellant vide Letter No. 29223 Dated 4.12.2023 and the appellant was granted an opportunity to examine the PIO's reply and list the deficiencies in writing to the PIO, with a copy to the Commission. The appellant pointed out deficiencies in writing to the PIO vide his Letter Dated 15.01.2024. Thereafter, the case was listed for 23.02.2024. At the last Hearing on 23.02.2024, the RTI application was discussed point-by-point and the Commission

3. At today's Hearing, the respondent PIO has submitted, a copy of a fresh, pointwise reply pertaining to point Nos. 3, 7 and 8 vide Letter No.8470 Dated 26.03.2024. The same has also been provided to the appellant vide Letter No. 8469 Dated 26.03.2024.

## Appeal Case No. 2990 of 2023

6. After hearing both parties and on perusing the facts on record, the Commission concludes that this RTI application has been adequately addressed by the respondent PIO. The Commission, has to adjudicate as per provisions mandated by RTI Act, 2005. The perception of the appellant that the RTI Act can be employed as a mechanism for redressal of his grievance regarding the allegedly illegal construction by a neighbor, is beyond the provisions of the RTI Act and so not within the jurisdictional boundaries of this Commission. The Commission advises the appellant to approach the competent forum or Court for redressal of his grievance as it is unable to step beyond the jurisdiction stipulated by the RTI Act.

7. In view of the above, there is no cause for further interference by the Commission. The Appeal is, accordingly, **Disposed of**.

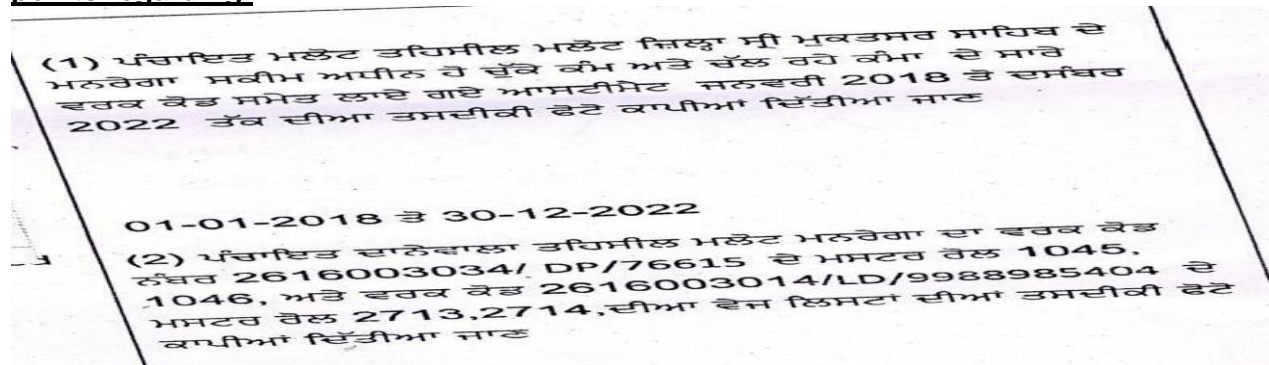

Harinder Singh, has been made to suffer harassment by the long delay in addressing his RTI application.

4. In view of the harassment and detriment caused to the appellant, Sh. Harinder Singh, this Commission deems it appropriate to award a **compensation of Rupees Five Thousand (Rs. 5,000.00)**. This is to be paid vide a crossed cheque / demand draft, by the Public Authority, in this instance, the office of BDPO, Nabha, within 30 days of receiving this Order. Proof of payment is to be submitted to this Commission.

5. Accordingly, the PIO has claimed exemption as per Section 24(4) of the RTI Act, 2005 which is as under:-

6. After due consideration to submissions by both the parties, the Commission concurs with the PIO's decision to withhold information sought, as per Section 24(4) of the RTI Act, 2005. Since, the information sought pertains to sensitive intelligence work by the Police Department and is not directly related to any allegation of corruption or Human Rights violation.

7. In view of the above, there is no further cause for action. The appeal is accordingly, **Disposed of.**
