4. However, the respondent, Sh. Manpreet Singh, submits that original record had already been submitted to the Office of the Registrar, Hon'ble Punjab and Haryana High Court in a sealed envelope in LPA No. 38 of 2024 in CWP No. 24705 of 2015; hence sought information cannot be supplied to the appellant at this stage. He further clarified that till date the original record has not been received back. Further, he submits that intimation in this regard has already been sent to the Commission, which is taken on record. Details of the pending case in which the original record had been submitted in the Hon'ble Punjab & Haryana High Court is given to the appellant during the course of hearing.

5. After having the detailed deliberations with both the parties and examining the case file, the respondent PIO is directed to supply the information after the receipt of the original record. As such no further directions can be given to the respondent PIO at this stage. Hence, the case is **disposed of & closed** with the liberty to the appellant to approach the Commission within one month, in case he has any further submissions to make.
