## Complaint Case No. 95/ 2019, 109/2019, 110/2019, 111/2019

## PRESENT: Sh.Sudhir Sharma as the Appellant Sh.Jatinder Singh, Jr. Assistant O/c NC Nabha for the Respondent

**ORDER:** This order should be considered in continuation to the previous order.

The case was first heard by Sh.A.S.Chanduraian, State Information Commissioner on 13.03.2019. Sh.Gagandeep Singh, JE appeared on behalf of the respondent who sought adjournment which was granted.

The case was again heard by this bench on **30.07.2019.** The complainant was absent and vide email informed that the PIO has not provided the information. The respondent was also absent.

Having gone through the file, the Commission observed that there has been an enormous delay of eight months in attending to the RTI application, the PIO was issued a **show cause notice** under section 20 of the RTI Act and directed to file reply on an affidavit. The PIO was again directed to provide the information to the complainant within 10 days.

The case was further heard on **06.11.2019.** The appellant was absent and telephonically sought exemption. The appellant further informed that the PIO has not provided the information.

The respondent present pleaded that he had recently joined this office on 23.07.2019 and the delay had occurred on the part of the earlier PIO. The respondent also submitted his reply which was taken on the file of the Commission. In the reply, the respondent stated that after assuming the charge, he immediately asked the concerned junior engineer Sh.Gaganpreet Singh vide letter dated 23.07.2019 to provide the information to the appellant. Sh.Gaganpreet Singh was again instructed vide letter dated 16.08.2019 to provide the information to the appellant and be present before the Commission on the date of hearing on 06.11.2019. Sh.Gaganpreet Singh has been transferred and now posted in NC- Bagha Purana.

The PIO was directed to submit a detailed reply to the show cause notice on an affidavit and be present on the next date of hearing.

The case was last heard on **23.01.2020.** The respondent present submitted a reply to the show cause notice on an affidavit which was taken on the file of the Commission. The respondent also submitted a list of officers posted as PIOs at NC Nabha from the date of filing of RTI application till date. The respondent also informed that Sh.Rakesh Garg was the PIO-cum-EO NC Nabha when the RTI application was filed and he is now posted as EO-MC Bhawanigarh.

Having gone through the list, the Commission observed that Sh.Rakesh Garg had a significant tenure of stay as PIO in NC Nabha, but the RTI application was not attended to by him. Sh.Rakesh Garg, EO-MC Bhawanigarh was directed to appear personally before the Commission on the next date of hearing and explain the reasons why the RTI application was not attended to within the time prescribed under the RTI Act.

#### Hearing dated 29.06.2020:

The case has come up for hearing today through video conferencing at DAC Patiala.

The respondent present pleaded that the information has been provided to the complainant. The complainant pleaded that the information is incomplete and the PIO has not provided the information as per the RTI application. The appellant further informed that he also filed first appeal before the First Appellate Authority on 12.02.2020 which directed the PIO vide order dated 04.03.2020 to supply the information within a week. However, the PIO has not provided the complete information.

Hearing both the parties, the appellant is directed to inspect the record by fixing a mutually convenient date and time with the PIO and get the relevant information. The PIO is directed to allow the inspection to the appellant and provide relevant information as per the RTI Act. If the information is not available, to give in writing on an affidavit that the information supplied is complete and no further information is available.

The Commission observes that the complainant in has sought information in CC-95/2019, CC-109/2019, CC-110/2019 & CC-111/2019 from the same department i.e. EO-NC Nabha, all four cases are clubbed together and the PIO is directed to provide information in all these cases as per the RTI Act.

In the last hearing, it was informed by Sh.Amrik Singh, EO-cum-PIO Nabha that the delay had occurred at the level of Sh.Rakesh Garg, PIO-EO, NC Nabha (Now transferred and posted as PIO-cum-EO -NC Bhawanigarh). Sh.Rakesh Garg, EO-MC Bhawanigarh (Earlier PIO-cum-EO NC Nabha) was directed to appear personally before the Commission on the next date of hearing and explain the reasons why the RTI application was not attended to within the time prescribed under the RTI Act. Sh.Rakesh Garg, EO-NC Bhawanigarh is absent nor has sent any reply to the show cause notice.

Keeping the above-mentioned facts of the case, it is clear that Sh.Rakesh Garg, EO-NC Bhawanigarh (earlier PIO-cum-EO, NC Nabha) is flouting the spirit of the RTI Act continuously. The PIO has not only shown utter disregard for the Commission's repeated orders to provide the information but has shown willful stubbornness in not replying to the Show Cause and not appearing before the commission despite various orders in complaint case No. CC-95/2019, CC-109/2019, CC-110/2019 & CC-111/2019

To secure an erring PIO's presence before the commission the Information Commission is empowered to issue warrants to Under Section 18(3) of the RTI Act. A bailable Warrant of the Sh.Rakesh Garg, EO-NC Bhawanigarh (earlier PIO-cum-EO,NC Nabha) is hereby issued through Senior Superintendent of Police, Sangrur for his presence before the Commission on **15.07.2020**.

To come up for further hearing on **15.07.2020 at 11.00 AM**.

## Complaint Case No. 898 of 2019 and 910 of 2019

## PRESENT: Sh.Bhagwant Singh as the Complainant Sh.Jaswinder Singh, Sr.Xen(Enforcement) PSPCL Patiala for the Respondent

## ORDER:

The case was first heard on 18.02.2020. The respondent present in CC-898/2019 pleaded that since the enquiry is pending and the information will be provided after the enquiry is completed. The Commission also received a letter on 10.2.2020 from the PIO-cum-Dy Chief Engineer/Enforcement, PSPCL Patiala stating that the enquiry is pending and the reply has been sent to the complainant vide letter dated 02.08.2019.

The commission observed that the complainant had also filed another complaint case No.910/2019 for seeking exactly the same information from the office of SDO(Rural)PSPCL Nabha. In this case, the Assistant Executive Engineer, Sub-Division(Rural) Nabha vide letter received in the Commission on 17.02.2020 had stated that the enquiry in this case was being conducted by Dy Superintending Engineer, Enforcement, PSPCL Patiala and sent copies of the correspondence done with them to the Commission.

The complainant highlighted that there is an ambiguity in the information that has been provided since in the document provided by the PIO in an earlier RTI application on 24.07.2017, it was stated that the account No.AP02/744 is in the name of Partap Singh s/o Bhag Singh. However, the reply submitted to the Commission by the AEE Nabha, it is stated that the account which was held in the name of Sh.Partap Singh s/o Sh.Bhag Singh has been transferred on 28.09.2006 vide new PDCO No.26/73152 in the name of Sh.Bhagat Singh s/o Sh.Kehar Singh with new account No.AP02/757.

Since the ambiguity pointed out by the complainant was justified, the Commission marked this to the Chief Engineer, Enforcement, PSPCL Patiala to look into the matter and ensure that the correct information is provided again and if there is any fraud, to conduct an enquiry and send enquiry report to the Commission.

Further since the information sought in CC-898/2019 was the same as sought in the CC No.910 of 2019, both the cases were clubbed together and the Chief Engineer, Enforcement, PSPCL Patiala was directed to provide complete status on the matter.

#### Hearing dated 29.06.2020:

The case has come up for hearing today through video conferencing at DAC Patiala. The respondent present pleaded that they have issued a letter to the concerned Tehsildar to inform the khasra number of the property at which the connection was released.

The PIO-PRTC Chandigarh was also directed to pay an amount of **Rs.2500/-** via demand draft drawn through Govt. Treasury as compensation to the appellant for the loss and detriment suffered by him of having to file the appeals and not getting information in time. The PIO was directed to duly inform the Commission of the compliance of the order and submit proof of having compensated the appellant.

The case has come up for hearing today through video conference facility available in the office of Deputy Commissioner, Patiala. The respondent present from the office of PRTC Chandigarh has submitted a copy of challan as a proof of having deposited the amount of penalty in the Govt Treasury which is taken on the file of the Commission. The respondent has also handed over a demand draft No.653620 drawn on SBI for Rs.2500/- to the appellant during the hearing.

Since the information has been provided, the amount of penalty has been deposited in the Govt treasury and the compensation has been provided to the appellant, no further course of action is required.

The PIO-cum- Deputy Chief Engineer/Operation Div, PSPCL Gurdaspur was absent. The PIO-cum-Dy Chief Engineer, Operational Division, PSPCL Gurdaspur was issued a show cause notice under Section 20 of the RTI Act 2005 and directed to file reply on an affidavit.

## Hearing dated 29.06.2020:
