In the reply, the respondent stated that the information sought by the appellant has got no relevance and the appellant may use the said information against the interest of the company or its directors and disclosure of information may harm the interest of the company. Moreover, the information has no larger public interest and the appellant may use the same to malign and harm the competitive position of the company as the appellant was once engaged in the company for immigration to Canada but was declared disqualified based on the eligibility parameters by the Technical Assessment Team of the Company and since then, the appellant is filing frivolous applications before the different authorities.

The reply of the respondent was taken on the file of the Commission and the case was adjourned for adjudication.

Appellant Case No. 3543 of 2018

The case was again heard on **21.05.2019.** The appellant was absent and vide email has sent reply. The reply of the appellant was taken on the file of the Commission. The case was adjourned for adjudication on the next date of hearing.

The case was last heard on **17.07.2019.** The respondent from the office of PUDA Mohali was present. The advocate representing WWICS reiterated their earlier plea that the information sought by the appellant has got no relevance and the disclosure of information has no larger public interest. The appellant was absent. The case was adjourned.

Hearing dated 29.10.2019:

Both the parties are absent. Sh.K.S.Rupal, advocate on behalf of WWICS Estates Pvt. Ltd. is present.

Having gone through the file and on the basis of the documents on the file, the Commission is of the view that the appellant has not been able to make out a case for higher public interest on the issue at hand, hence the appeal is dismissed and the case is closed.

The case is **disposed off and closed.**
