**ORDER**

This order may be read with reference to the previous order dated 24.04.2024 vide which case was adjourned for 29.05.2024. But on the request the respondent the case was fixed for hearing today i.e. 30.05.2024.

2. The respondent PIO filed an affidavit, duly sworn, as per the directions of the Commission. Also, an original affidavit, duly sworn, handed over to the appellant during the course of hearing and after receipt of the same, the appellant submits that he is satisfied with the same except the information pertaining to the Point No. 1 as the respondent supplied the information regarding Professors/Associate Professors instead of Teaching/Non-Teaching staff members, who left GNDU Amritsar. The sought information at Point No. 1 is as under:

'Provide the number of teaching/non-teaching staff members who left G.N.D.U Amritsar after taking No Objection certificate to join organization and G.N.D.U. competent authority asked them to request Last Pay certificate (LPC) through their current organization.'

After detailed deliberations with both the parties, the respondent PIO assured that information complete in all respects regarding teaching/non-teaching staff members pertaining to Point No. 1 will also be supplied to the appellant through registered post. He further assured that the information will be supplied to the appellant within two (02) weeks and requested to close the case with which the appellant agreed to.

4. Keeping in view the assurance given by the respondent, the Commission is of the view that no further action is required to be taken in this case. Hence, the case is **disposed of & closed**. The appellant is at liberty to approach the Commission within six (06) weeks, in case, he does not receive the same as has been assured by the respondent PIO.
