5. I am of the view that due to evasive attitude of the respondent PIO concerned,

the appellant has suffered a lot of detriments for not getting the requisite information, I

am of the view that compensation be awarded to the appellant, Sh. Yogesh Mahajan.

6. Hence, I award an interim compensation of Rs. 1,500/- (Rupees Fifteen Hundred

Only) to the appellant. The compensation amount must be paid by the respondent PIO

concerned through cheque or demand draft in favor of Yogesh Mahajan from the

account of Public Authority and not from the individual's account.
