## <u>ORDER</u>

 The appellant filed appeal in the Commission dated 09.10.2018 under the Life and Liberty clause and case was allotted to the Bench of Undersigned dated 22.10.2018.

2. Respondent, Sh. Vipin Kumar states that requisite information cannot be supplied to the appellant as it relates with third party. He submits a reply vide letter no. 10-A-I dated 29.10.2018 signed by the Deputy Commissioner of Police cum PIO, Jalandhar stating that as per Section 8(1) (A) and 8(1) (J) of the RTI Act cannot be supplied. In that reply he added that due to privacy and secrecy for security purpose requisite information cannot be supplied to the appellant. This letter is taken on record.

3. On this, appellant, Sh. Simarjeet Singh states that he requires only information relates with him in connection with point no. 2 and 3. He also mentioned that information relates with point no. 1 and 4 are still pending from the respondent PIO.

4. After hearing both the parties and examining the documents placed on record, I am of the view that requisite information is not a third party completely. Respondent PIO is directed to supply the complete requisite information in connection with point no. 1 and 4 along with directions to supply the requisite information relates with the appellant, Sh.

## APPEAL CASE NO. 3394 of 2018

Simarjeet Singh only in connection with point no. 2 and 3 by keeping the privacy and secrecy of information relates with third party before the next date of hearing positively. He is also directed to represent this case in person in person or through any of his representative(s) on the next date of hearing positively.

5. On this, respondent, Sh. Vipin Kumar requested for an adjournment in this case to supply the requisite information to the appellant.

6. Appellant, Sh. Simarjeet Singh requested for dated 27.11.2018 in this case.
