ORDER:

ORDER:

ORDER:

The appellant through RTI application dated 25.09.2018 has sought information on 10 points regarding copies of documents relating to election of Zila Parishad Zone Kokari Kalan-4 of Booth No.176 to 179 of village Talwandi Mallian – copy of marked electoral rolls, copy of signed counterfoils – copy of cassette of ideograph – name & designation of polling staff – name & designation of counting staff – name of micro observer – security staff – number of vehicles used and other information as enumerated in the RTI application concerning the office of SDM Dharamkot. The appellant was not satisfied with the reply of PIO dated 30.10.2018 after which the appellant filed first appeal before the First appellate Authority on 08.11.2028 which took no decision on the appeal.

The Commission ,however, makes it clear that the information, if it exists, even though sought in question form, it be provided.

The PIO is directed to relook at the RTI application and provide complete information to the appellant as per the RTI application under the RTI Act.
