ORDER:

1. The RTI application is dated 10.02.2021 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (Hereinafter FAA) on 15.02.2021 and the Second Appeal was filed in the Commission on 24.02.2021 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).
2. Notice of hearing was issued to the parties for 20.01.2021 by the Commission through Cisco Webex which was further postponed to 31.03.2021. As such, the case has been heard today through Cisco Webex. The appellant Shri Sanjeev Goyal has not come present to attend the hearing through Cisco Webex.
3. Shri Vikram Doriya, Superintendent/APIO O/o Executive Officer, Municipal Council, Sri Muktsar Sahib comes present to attend the hearing through Cisco Webex. He states that the information has been supplied to the appellant vide letter dated 08.03.2021 by registered post and that no response has been received from the appellant thereafter.

4. Shri Sanjeev Goyal, appellant is contacted on mobile phone. He admits the receipt of information, but he states that he is not satisfied with the information received as there are certain deficiencies in the information supplied.

5. The Bench advises the appellant to point out deficiencies to the PIO. The PIO is directed to remove the deficiencies pointed out by the appellant and supply the rectified information before the next hearing.
