The appellant, Sh. Sanjeev Kumar, who appeared in person in today's hearing, states that he visited the office of the respondent on the fixed date but the respondent has not presented the official record before him to identify the same.

Neither the respondent PIO nor any of his representative is present in today's hearing. He has also not sent any intimation regarding his non-availability. The Commission took a serious view of this casual approach of the respondent PIO, moreover, the requisite information has not been supplied by the respondent PIO to the information seeker even after the directions were given by the Commission vide orders dated 09.03.2021.

In view of the above, a show cause notice under Section 20 (1) of the RTI Act is issued to Public Information Officer concerned of office of Executive Engineer, P.W.D. (B & R), Provincial Division, Mansa, as to why penalty be not imposed upon him for willful delay/denial in supplying the information to the RTI applicant and why the compensation be not awarded to the information-seeker under the provisions of the RTI Act, 2005.

He may note that in case he does not file his submission and does not avail himself of the opportunity of personal hearing on the next date fixed through facility of Software/application 'CISCO Webex Meetings', it will be presumed that he has nothing to say and the Commission shall proceed to take further proceedings against him ex-parte. A copy of this order be sent to him through registered post.

Last opportunity is given to the respondent PIO concerned supply the certified copies of the required information to the appellant through registered post with a copy to the Commission by the next date of hearing.

An opportunity is also given to the appellant to confirm whether he has received the information or not. He is also advised to point out deficiencies, if any, in the information supplied to him, in writing, to the respondent PIO so that the same could be removed by the respondent concerned. He is also advised to represent his case in person or through his representative on the next date of hearing.

The case is adjourned to 17th August, 2021 (Tuesday) at 11:00 A. M. for hearing through facility of Software/application 'CISCO Webex Meetings'.
